INDIANA FEAR FARM GROUP HAUNTERS

RULES & REGULATIONS CONTRACT

The following is information pertaining to the monies that will be donated to your group or organization in trade for haunting at our attractions.

All donations will be given in cash to the group leader on the last night that your group haunts for us. We will require verification that the donation amount is correct as well as a signature accepting the donation from the group leader.

We would also ask that once all your members are on the property and accounted for by your group leader as well as our check-in attendant, we will require a signature each evening verifying that our numbers and your leader's numbers are the same. This will eliminate any confusion later.

Your group will be accountable to have the number of haunters, which must all meet the "haunter criteria" described in our Haunter Wanted Form, each evening that was agreed upon and noted on the Group Haunter Contract.

If your group should have more than the agreed number of haunters on any given night, your group will be compensated for the additional haunters. (Up to 5 additional haunters, if our other group numbers are not at capacity, we will compensate your group for all additional haunters :0)

However, if your group does not have the agreed number of haunters there is a double penalty. As well as if a haunter does not stay for the duration of the time the attractions are open, the double penalty will apply as well.

Explanation of the double penalty: For every one haunter that does not attend or that leaves before the attractions are closed, the group will be penalized for 2 haunters.

PLEASE UNDERSTAND THAT WE WANT TO DONATE AS MUCH AS POSSIBLE TO YOUR GROUP BUT WE ALSO HAVE TO HAVE SAFE GUARDS IN PLACE DUE TO THE NUMBER OF HAUNTERS IT TAKES TO RUN FEAR FARM.

(Example:

Your group agreed to provide 25 haunters but only 24 show up.

Your group will not be compensated for the 25th person that did not haunt, as well as, your group will not be compensated for one other haunter that did haunt. This would drop your total compensation number to 23 for the night.)

Suggested ways to avoid any penalties:

- 1. We strongly suggest that you give yourself some “cushion”. We understand that things happen, people get sick, etc. So it is for that reason we suggest that you schedule 2-5 extra haunters on any night that you will be haunting for us. These could be extra people in your group that will haunt as well and earn your group extra donations should everyone show up and stay for the duration of the evening. These extras could also be adults that come along and only haunt if your group finds that they have less than the agreed upon number.**
- 2. We suggest that you discuss these stipulations with the members of your group as well as provide them with a copy of the FAQ’s page that we have provided you with. This will make them aware that though this is a very fun and unique way of fundraising, it is a business and essentially it is a lot like a “job” that they are expected to do and that their group is earning money from. It also helps them understand that their actions can affect the entire group. They will be part of a very large show that crowds line up to see every year and it is our duty as well as our livelihood to give them the best show possible and to do that we need a designated amount of haunters each evening.**
- 3. Last, we cover this in our FAQ’s page but always like to stress that importance of this. It is very important that your members understand that it is not enough to simply “show up”. As stated above, this is a show, a very large and elaborate show that requires its “actors” and “haunters” to give it their best from start to finish. We do our very best to “partner” as many people with or close to other people in their group but we cannot please everyone so we ask that your people be easy to work with and willing to do whatever is asked of them and to do it to the best of their ability. In return we will, along with donating to your group, do everything we can to ensure that your group has an awesome time while on our farm AS WELL AS PROVIDE DRINKS AND SNACKS:0)**

You will not find a better group of people to raise money with, we truly care about our customers, our product and our haunters and want everyone to have a safe and memorable experience! We are super excited to work with your group and look forward to meeting everyone!!
